AN INTRODUCTION

C-R.I.S.K. Corporation ("C-RISK" or "SPIV!CA") is a Canadian federally incorporated entity that received its charter in August 2004. C-RISK is the securitisation vehicle of Economic Reform Corporation that has been mandated to undertake all tasks and measures that must be undertaken prior to and during a project to prevent possible loss of funds, materials, equipment, goods, and services – regardless of whether insurance policies are taken out or not in and through (1) secured project investment vehicles and/or (2) special purpose infrastructure vehicles.

The Corporation is formed to undertake Canadian risk investment securitisation, risk management, risk mitigation and transfer, and risk coverage. It may enhance, supplement, supply, collaborate, and cooperate with Canadian Crown Corporations, insurers and reinsurers, underwriters and financial institutions, and development banks to encourage private investors, institutions and governments to pool funds, assets and alike, in order to further economic developments in host countries.

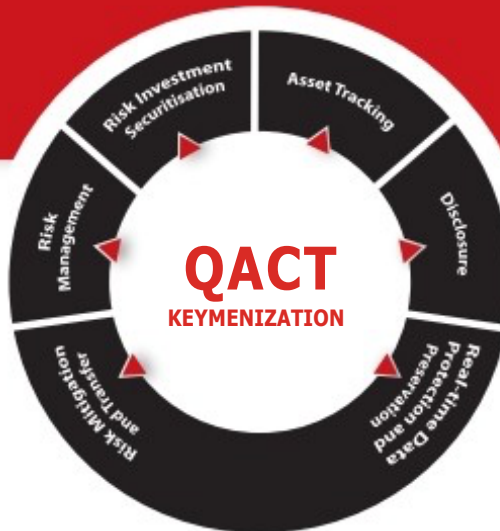

SPIV.CA™ – The secured project investment vehicles, sovereign infrastructure finance vehicles, hybrid development iSPIV™, and all special purpose products of C-RISK are made available exclusively to Infrabanx Network!™ and Conscribe Network!™, in and through SPIV.CA™. Its derivative products may be used to enhance, enforce, ensure compliance, certify, supplement, and reinforce export credit agencies, insurers and reinsurers, underwriters and financial institutions, governments, and private investors position with respect to their investment relating to economic reform and trade activities pertaining thereto.

R|A|R|E™ is the custody and liquidity reserve compliance and enforcement product of C-RISK designed to ascertain that adequate risk-weighted asset collateralisation levels are always maintained and available in order to meet the timely redemption obligations of an investment.

I|R|O|N™ is the insurance, reinsurance, compliance and enforcement product designed to provide all required assurance, insurance and reinsurance coverages necessary for the protection of project owners, investors, sector sponsors, prime/subcontractors, servicers, members, and participants involved in a given transaction undertaken by eligible registrants of Infrabanx Network!™ via Conscribe-It!™.

S|U|R|E™ is the surety compliance and enforcement product of C-RISK that is used to equip and power the bank products of Infrabanx™. It provides an accountholder with security and liquidity for timely redemption, fulfilment of an obligation, or secured debt payment.

Keymenization™ (or Keymen™) product encompasses the human resource aspect of compliance and enforcement mechanism through C-RISK's risk management division, SURIX!CA™ in Canada and its territories.

imailex™ is the information exchange product of C-RISK used for data verification, authentication, assurance, compliance, and enforcement.
